CONTEST RULES

Commencing 12:01AM EST on **September 9th**, 2024, and ending at 11:59PM EST on **December 6th**, 2024. Eligible Persons may enter this Contest being held by HUB International Ontario Limited.

ELIGIBLE PERSON

To be eligible for the Contest, an individual must request a Home and/or Auto quote by calling 905-582-3056 or submitting the form at <https://www.hubinternational.com/shopinsurance/>, during the Contest Period and in addition must be during the Contest Period:

- 18 or older.
- a resident of Ontario

HOW TO ENTER

NO PURCHASE NECESSARY TO ENTER. There is a limit of one (1) entry per household during the Contest Period. Any Eligible Persons who are not Provisional Winners in any given draw shall be re-entered in a subsequent draw, if any.

CONTEST DATES AND TIMES

DRAW
